

ABOUT US

Action For Animals Humane Society (AFA) is a 501c3 non-profit, non-government funded, no-kill shelter that keeps animals free from the threat of unwarranted euthanasia. We rescue, rehabilitate and re-home abused, neglected and stray dogs and cats.

AFA was founded in 1983 using a series of foster homes to save and care for abandoned animals, then ultimately adopting them to carefully screened families. In 1992 our very first kennel opened in rural Derry Township. After outgrowing the space, we moved to a larger location on Route 217, Latrobe during the spring of 2007.

Our facilities include a surgical wing, isolation building, Tigre Pavilion (cageless open-air cattery), indoor dog runs, intake rooms, separate dog and cat wings, private visitation areas, Blessed's Dog Park with walking paths and outdoor covered play areas.



MISSION STATEMENT: Action For Animals Humane Society was founded in 1983 to shelter and provide care for abused, abandoned and stray dogs and cats of Westmoreland County. We adopt animals into responsible homes and vigorously promote the spaying and neutering of all pets to eliminate the cruelty of pet overpopulation. 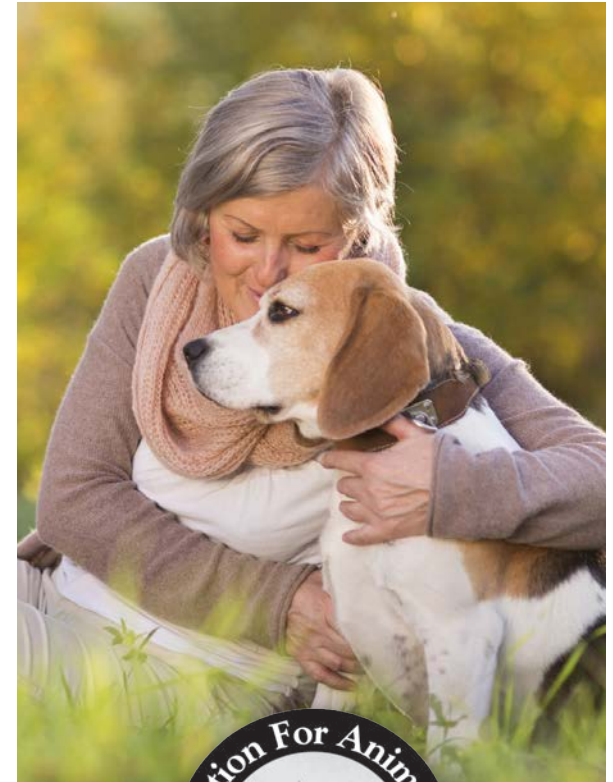

Ways you can help sustain our work now and in the future

LIFE INSURANCE

Making Action For Animals the beneficiary of a life insurance policy is an easy way to make a meaningful contribution. A life insurance gift can be an already existing policy you have or a new policy. If you have an existing policy you would like to leave to Action For Animals simply change the beneficiary of the policy to Action For Animals Humane Society.

WILL

Your legacy will continue after you are gone. Sample Bequest Language: I give, devise, and bequeath to Action For Animals HS, Federal Tax Identification Number, P.O. Box 814, Latrobe, PA, 15650, the sum of \$_____ (or describe the real or personal property or estate portion) to be used for its general purposes.

RETIREMENT BENEFICIARY FORMS

Simply list "Action For Animals" as relationship to beneficiary, plus name, address, and Federal Tax Identification Number of Action For Animals HS.

RESTRICTED DONATION

Your gift will only be used as you specify.

UNRESTRICTED DONATION

Your gift of cash or securities at any time will be used for shelter operating costs or an area of greatest need.

ENDOWMENT DONATION

Your contribution goes directly into the Community Fund of Westmoreland County (Action For Animals must be designated as the recipient).

CHARITABLE TRUST

A charitable trust can be established through your attorney to set aside money or other assets to provide income for a donor, such as Action For Animals. Charitable trusts have the additional advantage of establishing a tax-deductible gift for qualified non-profits such as Action For Animals.

CHARITABLE REMAINDER TRUST

This type of trust is established by transferring money or assets to a trustee to be held for the benefit of Action For Animals. The donor specifies the amount of income to distributed, to whom it is to be paid and the duration of payments. At the death of the last beneficiary, the trust will terminate and Action For Animals will receive the remainder.
